Due to Covid-19 restrictions, rather than have candidates circulate nominating petitions, the CCF is asking candidates to submit individual remote petition signatures from qualified **Contra Costa County registered voters** that reside in area codes **94525** or **94569**.

Please print the attached form titled, "CROCKETT COMMUNITY FOUNDATION NOMINATING SIGNATURE", have individuals sign it, and either scan it and return to you (the candidate), or alternately have signers take a picture of the printed signed form with their phone and mail or text it back to you (the candidate). Forms will also be available on our website, www.crockettcommunityfoundation.org.

Please return nominating petition coversheet, candidate's statement of qualifications, and all remote signatures (a minimum of 20 signatures is required). It is suggested that you obtain **more than 20 signatures** to avoid possible disqualification based on the possibility that some signers may not be **current registered voters**, or that their name/address is illegible. Each person submitting a signature must write his/her name, address (**as registered to vote**) month, day and year of signing,

NOTE

Eligibility Requirements for Directors

Only persons who are (a) citizens eligible to vote in State of California elections and duly registered with the Contra Costa County Registrar of Voters, and (b) residents of Crockett, Crotona, Valona, Tormey and Port Costa, who have lived within US Post Office Codes 94525 or 94569, as it may exist from time to time, for at least one year prior to the date established for elections of directors, are eligible to serve on the Board of Directors. For 2020, the election date has been established as December 4, and candidates must have been residents of Crockett, Crotona, Valona, Tormey and Port Costa from December 4, 2019 or before.

The person running for Director of the Crockett Community Foundation must obtain a minimum of 20 signatures from **qualified registered voters** residing in Crockett, Crotona, Valona, Tormey and Port Costa, who have lived within US Post Office codes 94525 or 94569, as it may exist from time to time, and who are eligible to vote in the Contra Costa County general elections. Prospective candidates are advised to obtain more than 20 signatures to avoid possible disqualification based on the possibility that some signers may not be current registered voters, or that **their name/address is illegible**.

Each person submitting a signature must write his/her name, address (**as registered to vote**) month, day and year of signing.

All signatures, this form and the candidate's statement of qualifications must be mailed to the Crockett Community Foundation, PO Box 155, Crockett, California, 94525, and must be postmarked on or before July 31, 2020.

When the Board of Directors of the Crockett Community Foundation determines that 20 signatures on the petition are from qualified residents, the Board will notify the petitioner no later than September 8, 2020 that her/his name will be placed on the ballot as a candidate for Director.
